4. The highest bidder must deposit 50% of the bid amount within three (03) working days of being declared the successful bidder.
5. The remaining 50% of the bid amount shall be deposited on or before the day of transfer of the vehicle and execution of the sale deed/documents. After full payment and completion of documentation, the vehicle will be delivered to the successful bidder, who shall be responsible for making their own arrangements to take delivery of the auctioned vehicle.
6. Conditional bids will not be entertained.
7. The Embassy of India reserves the right, at its discretion, to reject or accept any or all bids at any time without assigning any reason.
8. It shall be presumed that the bidder has fully inspected the car before the auction. The Embassy of India will not be responsible for and shall not entertain any complaint regarding any defect in the vehicle.
